

LANSING SWIM ORGANIZATION (L.S.O.)  
 CONTRACT DUES RETURNING SWIMMERS - SEPTEMBER, 2011 – JULY, 2012

(FORM #1 FOR SIGNATURE OF RECEIPT)

The Lansing Swim Organization, (hereinafter referred to as L.S.O.), is a non-profit competitive swim team. We need to pay our coaches, liability insurance, conference fees, charter membership, Indiana Swimmer fees at Duals, and other incidentals.

New swimmers joining L.S.O. will be required to pay a non-refundable **\$54.00 deposit** upon their acceptance to the team. This deposit will allow the swimmer(s) a two week trial period during which time they can decide if L.S.O. is for them. After the two week trial period, if the swimmer joins the team, the \$54.00 becomes part of the tuition payment, but again, is a non-refundable deposit should the swimmer decide not to join the team. By agreeing to swim with L.S.O., after the two week trial period, you agree to pay the full amount of dues. L.S.O. has held a position for your swimmer. If you should decide not to swim for L.S.O., this position held by your swimmer becomes vacant and cannot be filled during the season. Therefore, you are agreeing to pay the dues in full.

| Conference Fee                    | This fee is <b>per swimmer</b> per year. This is required by the Northwest Indiana Swim Conference for all members.   | \$ 14.00         |
| U.S. Swim Card Fee                | This fee <b>per swimmer</b> per year. It is mandatory for all swimmers.   | \$ 54.00         |
| Fundraising Fee                   | These tickets are for the Dance, Raffle and Pancake Breakfast. <i>(You can resell these tickets).</i> This is per family not per swimmer.   | \$300.00         |

If you fail to make the required payment by the 15th the each month, your child will not be able to swim until the payment is made. Failure to pay all tuition, fees, and fines on time each month can result in your swimmer's ineligibility to receive his or her end of the season awards.

| Intra-squad & Dual Fees                                 | Intra-squad and Dual meets are mandatory for all swimmers. The coach will enter the entire team in events based on total attendance. If you are unable to participate in one of these meets, you must indicate the swimmer's name on the "Sign Out" sheet located on the bulletin board. <i>(A fee will be charged for NO SHOWS!)</i> | \$ 5.00  |
| NSF Checks  | You will be responsible for the bank charge to L.S.O., plus an additional handling charge after one (1) NSF check. Afterwards we will only accept cash payments.  | \$ 5.00  |
| Relay Fines   | Meet Entry Envelopes have a line to check if your swimmer is available for relays on Saturday and Sunday. You are not charged for this relay, L.S.O. covers the cost of relays at Invites. However, if your swimmer leaves early the team is still required to pay that fee, so that cost will be passed on to you.                   | \$ 5.00  |
| Late Pick-Up Fee*                                       | If your swimmer is not picked up on time following the scheduled practice time, there will be a 15 minute fee.  | \$ 12.00 |

These contract terms should be read in detail. A signature page confirming that all parents have read and agreed to the terms of this contract is in your swim packet. You must sign and acknowledge receipt of the L.S.O. Dues Contract, Form #1, on the signature page. This signature page must be returned to the Vice-President (or mailbox), immediately, or your swimmer will not be allowed to participate.
